

TURN-BY-TURN DIRECTIONS

SHE RUNS GRAND RAPIDS 2023 (SUNDAY, APRIL 30, 2023 – 7:30 AM START)

Revised Half Marathon Course -- (highlights/neighborhoods in yellow)

START on Ottawa Avenue adjacent to Calder Plaza (Downtown Neighborhood District)

South on Ottawa to Fulton (Downtown Business District, The BOB)

Left (east) on Fulton to Ionia (Van Andel Arena)

Right (south) on Ionia to Oakes (Arena District)

Right (west) on Oakes to Cesar Chavez Avenue (Studio Park, Heartside Neighborhood)

Left (south) on Cesar Chavez to Ellsworth (Intersection, Founders)

Left (southeast) on Ellsworth/Century to Sheridan (Ballet, Antique Alley)

Right (west) on Sheridan to Martin Luther King Jr. Street

Cross MLKJ and continue south on Sheridan to Hall (Roosevelt Park Neighborhood)

Right (west) on Hall to Godfrey (Hispanic Center, downhill switchback)

Right (west) on Godfrey (using wide sidewalk on south side of street) to Oxford Street (Black Hills Neighborhood)

Left (south) on Oxford Street to the Oxford Trail

Right (west) on Oxford Trail, crossing river on Bridge and go right on trail; join Kent Trails near Zoo and continue on trail south along river and back along the trail next to Butterworth, exiting Trail at the Kent County Parks trailhead/parking lot off Butterworth

Right (north) on Butterworth in northbound lane to JBP Park Street (John Ball Area Neighbors)

Left (north) on JBP to Park Street in lane closest to the Park (John Ball Park on the left)

Left (west) into JBP, running on the driveway south and then right (east) on driveway toward circle drive; go right way around circle drive to paved path that goes out to Fulton

Right (east) onto Fulton to Valley

Left (north) on Valley to Lake Michigan Drive

Right (east) on Lake Michigan Drive, crossing to the north side of the road and staying in bike and westbound lane, to Seward

Left (north) on Seward, running in the nb lane, to Sixth Street (West Grand Neighborhood, Bridge Street Market)

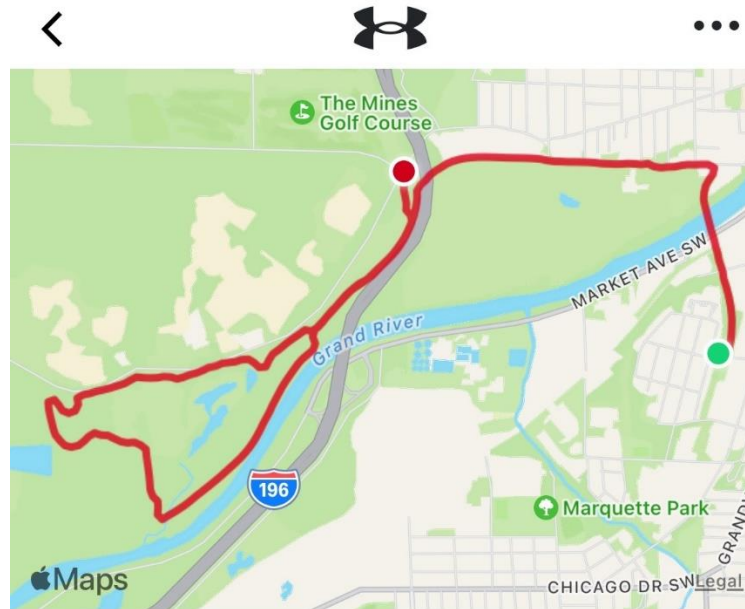
Right (east) on Sixth to Division (Sixth Street Bridge, Monroe North Business District)

Right (south) on Division to Lyon

Right (west) on Lyon to Ottawa (Kent County Courthouse)

Right (north) on Ottawa Avenue to the FINISH LINE
